### Managing Health and Safety Risks

(12 learning hours)

The ILO estimates that some 2.3 million people around the world succumb to work-related accidents or diseases every year; this corresponds to more than 6,000 deaths every single day.

This course provides an essential understanding of why employees should and how they can proactively play their role in managing health and safety within their area of work. Real-life case studies highlight the impact of events, along with video, discussion, group and reflective activities to understand how the theory applies to individuals' own workplace scenarios.

This is a two-day courses, delivered in a live, online learning environment.

The course is aimed at those with health and safety responsibilities as part of their roles:

- Managers who are responsible for the health and safety of their teams and their area of work
- Those working in disciplines where there is cross-over with health and safety, such as HR, facilities, and compliance
- Small business owners with overall responsibility for health and safety in their organisation
- Other workers who need an essential understanding of health and safety so they can

effectively contribute to the management of health and safety in their workplace.

#### **LEARNING OUTCOMES**

Participants will gain:

- An appreciation of why health and safety matters to the organisation, including how it relates to the wider risk management of the organisation, and their role in ensuring good health and safety management.
- An overview of the key principles and processes involved in managing health and safety, that can be applied to any organisation, industry or location.
- The ability to conduct a risk assessment, investigate an incident and set action plans.
- Knowledge of the critical role of culture and people and the key leadership behaviours needed to engage with their teams and those more senior.
- An appreciation of the evolving nature of health and safety risks.
- Understanding of sources of reliable and relevant information, to proactively manage health and safety within an area of responsibility.

### NEBOSH IIRSM Certificate in Managing Risk

The NEBOSH IIRSM Certificate in Managing Risk can help you become better equipped to identify, evaluate, communicate and act on risk.

This qualification is available via e-learning, which means you can complete your studies at a time, place, and pace convenient to you. It will take a minimum of 28 hours to complete the NEBOSH IIRSM Certificate in Managing Risk course and a further hour for the assessment.

The qualification is relevant for anyone who wants to be able to identify, evaluate, and manage business risks and understand their impacts for an organisation, as well as all decision-makers or those who simply have an interest in risk management and are looking for CPD opportunities.

It is particularly relevant for risk professionals looking to gain a broader view of risk beyond a specialism such as health and safety, quality, or business continuity.
